

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.fleurdelis-christmaslights.com> and Fleur de Lis Christmas Lights and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fleur de Lis Christmas Lights include <https://www.fleurdelischristmaslights.com> and Fleur de Lis Christmas Lights. The Fleur de Lis Christmas Lights website is a Professional services. site. By using the Fleur de Lis Christmas Lights website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Fleur de Lis Christmas Lights may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Fleur de Lis Christmas Lights's public message boards, this information may be collected and used by others.

Automatically Collected Information

- SSL Protocol

Right to Deletion

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
